Organizations lack Integrity will perish: Sri KV Chowdary, CVC

He advised the organizations to develop a secured whistle blow mechanism where remedial measures would be taken in a systematic manner. He mentioned that integrity play a vital role in enhancing the ethical values in the society. He said that the Commission had introduced various outreach initiatives to create/propagate the ideals of good governance and ethical values to bring out good corporate culture in the society. He advised the organizations not to entertain any anonymous complaints and develop a vigil blow mechanism to redress the grievances. He said that vigilance is primarily a systems analyst and stressed the need to look at the standard operating procedures and guidelines to bring out a good governance. Sri PK Rath, CMD, RINL in his welcome address said that RINL has included accountability and ethics in its core values of the organization and adopted several mechanisms to enhance transparency in its work procedures.
