PROGRAMMES TO ADVANCE UNDERSTANDING OF RTI (SECTION 26)

The primary objective of the RTI Act 2005 is promoting transparency and accountability in the working of the public authority to contain corruption and to hold the government and their instrumentalities accountable to the government.

The Act is applicable to all public authorities whose obligation for disclosure of information has been clearly spelt out in the Act.

In view of the above and in order to educate the employees of RINL on the RTI Act 2005, an One hour session on “the Importance and Implementation of RTI Act 2005” has been conducted during a Two-day programme on 12 occasions (25-26.04.2023, 16-17.05.2023, 12-13.06.2023, 17-18.07.2023, 02-03.08.2023, 01-02.09.2023, 04-05.10.2023, 04-05.01.2024, 05-06.02.2024, 20-21.02.2024, 01-02.03.2024 and 25-26.03.2024) covering around 545 employees including CPIO and APIO during the year 2023 – 2024 as a part of the Preventive Vigilance programme.
