

## Frequently Asked Questions

**1) What is the eligibility to register for the Internship/Project training at RINL-VSP?**

Ans) Only the Bonafide Student who is studying Engg. (or) M.Sc./MCA/M.Tech (or) B.Sc/B.Com/B.L/BBA/MBA are eligible. All Students have to register 'Online' for Internship/Summer Internship training at RINL-VSP using the link Proj.Trainee Registration in [www.vizagsteel.com](http://www.vizagsteel.com) (<https://web.vizagsteel.com/ptms/>)

*(Note: Students under the course category of Correspondence/Part-time/Distance mode/Online mode are not eligible)*

**2) How many options can a student give in the Trainee login?**

Ans) A student can choose 5(five) options includes selection of different project titles and different dates.

**3) What will be the next step after the Pending status in PTMS?**

Ans) You have successfully submitted the application in PTMS. However, you will receive an email to your email account registered in PTMS stating the status of confirmation / rejection of your internship with RINL.

**4) Shall I pay the fee before the joining date?**

Ans) Yes. On confirmation of the internship date allotment, the internship fee may be paid on their joining date (or) prior to joining date at any Bank of Baroda branch. Fee once paid will not be refunded under any circumstances.

**5) Is it possible to reduce/extend the duration of the internship?**

Ans) No. The duration of the internship shall not be reduced / extended.

**6) Can I claim to get the internship fee refunded?**

Ans) No, the fee once paid will not be refunded.

**7) Do I get any stipend during internship?**

Ans) No stipend shall be paid to the interns.

**8) Shall I get hostel accommodation?**

Ans) Hostel accommodation is very limited.

- There will be a nominal fee for the allotted accommodation.
- Accommodation will be allotted on first-cum-first-serve basis only on the day of joining/admission for internship.
- For male candidates, hostel accommodation will be on sharing basis
- For female candidates, the accommodation will be at quarters on sharing basis with other female candidates only.
- The accommodation will be strictly subject to availability only.
- Allotment of accommodation [hostel (for male)/quarter (for female)] on prior admission/joining day will not be entertained.

**9) Is safety helmet and safety shoe mandatory? Will it be provided by RINL- VSP?**

Ans) It is mandatory to wear safety helmet and shoe and it is to be borne by the individuals only

**10) What is the distance from Visakhapatnam Railway Station to Learning & Development Centre, Visakhapatnam Steel Plant?**

Ans) Approximately 25 Km.

**11) Is the transportation provided by RINL-VSP?**

Ans) No. The individuals have to make their own arrangements for their local movement.

**12) Shall I alter the joining date?**

Ans) No. The student needs to report only on the date of joining.

**13) Where to report for joining the internship of RINL-VSP?**

Ans) On receipt of email with regard to the project confirmation, the student shall report to Room 206, 2nd Floor, Learning & Development Centre (L&DC), Visakhapatnam Steel Plant, Visakhapatnam, at 9.30AM on the day of joining with all required documents

**14) What are the timings during the internship /project training?**

Ans) 9AM-5PM every day except on Sundays and Holidays of the company.

**15) What are the required documents to be submitted by the student?**

Ans) (i) Request Letter in original, (ii) joining report (to be downloaded from the website), (iii) Gate pass application affixed with passport size photo and (iv) Challan for proof of internship fee paid

**16) Do I need to submit the project report after completion of the project to L&DC?**

Ans) Yes, you need to submit both soft & hard copy of the project report duly certified by project guide of the dept./HoD for issuing e-certificate.
