### I. COMPANY PROFILE

Rashtriya Ispat Nigam Limited (RINL) was incorporated under the Indian companies Act, 1956 with the objective to be a self supporting, growing company in production of steel with continuous improvement in productivity, quality and consumer satisfaction. It is a Schedule 'A' Navratna CPSE in Steel Sector, with the administrative jurisdiction of Ministry of Steel. The company employed 16824 regular employees (Executives 5577, and Non-Executives 11247) as on 31.03.2021.

Its Registered and Corporate offices are at Visakhapatnam, Andhra Pradesh.

The authorized and paid up capital of the Company was Rs.8000 crore and Rs.4889.85 crore respectively as on 31.3.2021.

The shareholding of the Government of India in the company is 100%.

CCEA on 27th January 2021 has given in-principal approval for 100% strategic disinvestment of GoI shareholding in RINL along with management control by way of privatization.

# **II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Projects) is a member of the Board of Directors and reports to the Chairman and Managing Director. He/ she is responsible for providing direction to the Company's expansion plan and supervision as well as completion thereof within scheduled time. He/ she is required to achieve the highest standards of efficiency and productivity to bring the implementation of projects at par with international levels of excellence

The applicant should possess adequate technical/operational/Project management experience at a senior level in an organization of repute, out of which at least five years during the last ten years should have been in Project Planning & Management/ Design & Consultancy. Experience in Metals Sector is desirable.
