## **1.0 Introduction :**

- 1.1 Rashtriya Ispat Nigam Ltd (RINL), a Public Sector undertaking under the Ministry of Steel, Govt. of India, located in the Port city of Visakhapatnam, India and having an annual production capacity of 7.3 million tons of crude steel.
- 1.2 To broaden the supplier-base of Sea Water Magnesite (SWM). RINL invites **Expression of Interest (EOI)** from eligible reputed Manufacturers.
- 1.3 The Technical Specifications of the SWM envisaged to be procured through this EOI is enclosed at **ANNEXURE – I**. 3. Crystal size should be measured by linear intercept method with a multiplication factor of 1.62.
4. Material should be packed in suitable sea-worthy bags of 1.0 MT to 1.35 MT with inner P.E. lining.
