TRAINING & STIPEND :

- Candidates selected will be required to undergo training for a period of twenty four (24) months, which may be extended for cases where progress during training is found not satisfactory.
- During Training, candidates will be paid a monthly stipend of ₹10,700/- (consolidated) during the first year and a monthly stipend of ₹12,200/- (consolidated) during the remaining period of training.
- On satisfactory completion of training, candidates will be considered for appointment on probation to a regular post in the pay scales mentioned above against each post.

COST TO COMPANY (CTC) (After Training Period):
