2.	Upper Age Limit	55 years as on 01-07-2019
3.	Minimum Qualification & Experience	Degree in Medicine i.e. MBBS recognized by the Medical Council of India Post Graduate Degree/DNB/PG Diploma in Radiology from a University/Institute recognized by the Medical Council of India along with Permanent Registration Certification from either State Medical Council or MCI Minimum Two years Post qualification experience in Radiology discipline as on 01-07-2019 is desirable. In exceptional cases candidates with one year Post qualification experience may be considered.
4.	Duration of Engagement	Engagement would be initially for Two Years from the date of joining. The contract may be extended on Annual basis subsequently at the discretion of the Management. Each term will be fresh contract and at the end of tenure period, contract will be deemed to have expired. In case of extension, the extended tenure shall be treated as fresh contract without any continuity of service.
5.	Working Hours	8 hours per day either in shift duty hours (i.e., A/B/C/Gen shifts) or in split Duty timings depending on the need, on all working days. 9.	Medical Facility	Free Medical facility to self, spouse and dependent family members will be provided to the extent available at VSGH
10.	Termination of Contract	The contract will stand terminated at completion of the prescribed tenure. The contract may also be terminated during the tenure with two month's notice in writing by either side.
