- 2. The candidates should bring the following while coming for Certificate Verification:
 - i. Bio-data form duly filled in and signed (format available in Vizagsteel website).
 - ii. Two recent passport size photographs with blue background.
 - iii. Copy of Online test Registration Slip.
 - iv. Original Matriculation/Secondary School Certificate issued by University/Board recording Date of Birth and also a self-attested photocopy thereof. No other documents will be accepted as proof of Date of Birth.
 - v. Qualification & Experience Certificates as per notification No.03/2019/Fixed Term Tenure.
 - vi. OBC category candidates are required to produce OBC (Non-Creamy Layer) Certificate in the prescribed format issued not earlier than one year by the Competent Authority.
 - vii. Photo Attestation for the Caste certificate (OBC) duly signed by a Gazetted Officer of the Central / State Government (format available in Vizagsteel Website).
 - viii. No Objection Certificate from the present employer, in case of candidates employed in Government Department / PSU / Autonomous Body.
 - ix. Original Employment Exchange Registration Card and also a self attested photocopy thereof.
 - x. Original Permanent Account Number Card (PAN Card) and also a self attested photocopy thereof.
 - xi. Original Aadhar Card (Aadhar Card) and also a self attested photocopy thereof.
- 3. The Medical Examination will be conducted as per the prevailing medical examination rules, available at "Careers" page of www.vizagsteel.com.
- 4. The Medical Examination may spread over the whole day and may continue on the next day also. For this purpose you may have to stay one or two days more and you have to make your own arrangements for the same.
- 5. Candidates must take clearance from the authorities before leaving Visakha Steel General Hospital regarding completion of their medical examination.
- 6. The candidates, who are found medically fit, shall report for joining on 14.02.2020 at HR-Rectt. Section, Main Admn. Bldg., Visakhapatnam Steel Plant, Visakhapatnam-530031.
- 7. Candidates who are found "unfit" in the medical examination will be intimated separately through email.
- 8. Candidature of the individuals is provisional and subject to meeting the prescribed eligibility conditions mentioned in the Employment Notification / Recruitment Advertisement No.03/2019/Fixed Term Tenure and required medical standards in vogue. If at any stage it is found that a candidate is not eligible for the selection, his/her candidature will be rejected.
