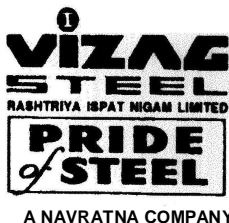

### **Query No. 3:**

### **Reply:**

In the event of the SELLER'S failure to deliver the MATERIAL within the time(s) agreed to, the SELLER shall have to pay as liquidated damages (and not by way of penalty), a sum equivalent to half percent of the price of any MATERIAL which the SELLER has failed to deliver, as aforesaid, for each and every week (part of a week being treated as a full week) during which the MATERIAL are not delivered after the contracted delivery period provided, however, such liquidated damages shall not apply to any period of extension granted by the PURCHASER under Force Majeure conditions given under Clause 19.0 herein below. The maximum amount of Liquidated Damages levied on any rake will be 10% of the value of the MATERIAL in that rake. Delivery of the MATERIAL after the same has become liable for levy of liquidated damages under this Clause shall not operate as a waiver of this right. The criteria for levying LD shall be based on the number of rakes received in a month against the scheduled number of rakes due for delivery in a month.

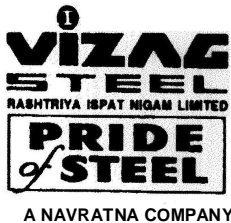

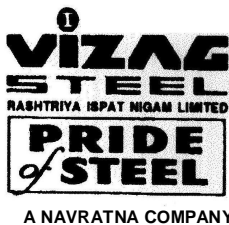
