Reply:

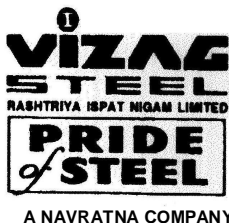
No. Quarters agreement with MCF Lalgunj is not expired in December, 2019.

This query does not fall under the definition of information or record as per the Section 2(f) of RTI Act.

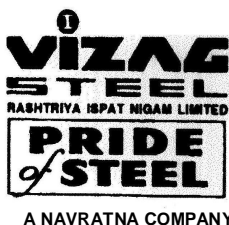
Query No. 6:
