 - v) Degree Certificate (Provisional / Final), in original, and mark sheets (of all years/semesters) thereof and

also a self attested photocopy of each.

Notes:

- (a) Where there is CGPA/CPI system of evaluation, certificate indicating the equivalent percentage of marks obtained from University should be produced.
- **(b)** Candidates who do not produce their Degree Certificate (Provisional / Final), in original, will not be interviewed.
