**Reply:**

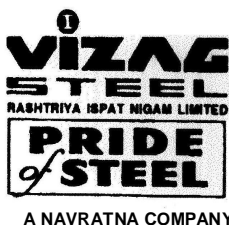

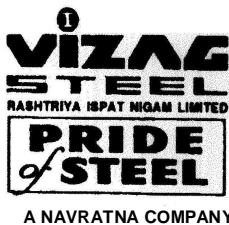
