Is there any chance that this Management Trainees recruitment will be cancelled?

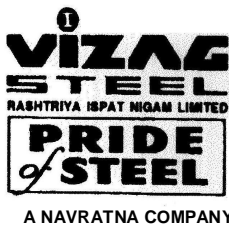

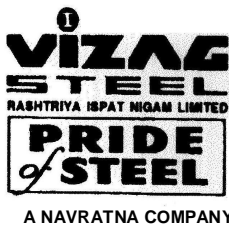
