Reply:

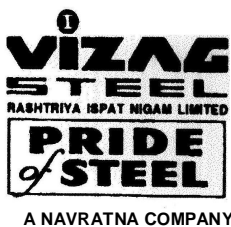
RINL purchased houses alongwith land directly from AP Housing Board and possession was taken-over in the year 1980-81 by paying the requisite cost.

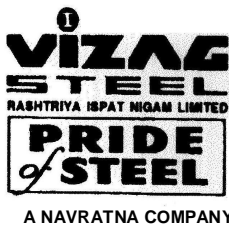
