Detail procedure of dealership.

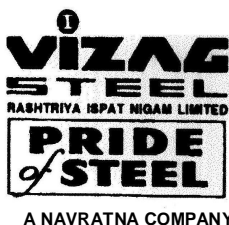

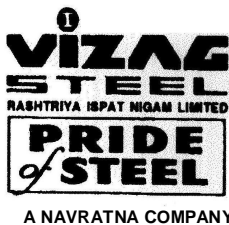
