I am seeking the information in the larger public interest as the above two persons being Hindus (I believe) with their undue influence and other brute force they usurped our small Christian Community in Ukkunagaram Church (Christ the Saviour Church Ukkunagaram), drafted their own bye laws, became advisors for Christian Community, their powers, among other things, include formation of Executive Committee for the Church and more painful thing is that they kept the power to select the Holy Priest for the church. We are denied of our right to choose our own priest. A copy of bye laws is attached for ready reference. Thus, with these unlawful actions by the above persons, the legal rights of our minority community are affected and hence the information sought under RTI Act-2005.

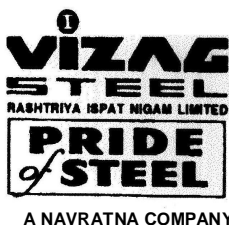
Reply:

The information sought by the applicant cannot be provided under Section 8(1)(J) of the RTI Act, 2005 which states that :

"information which relates to personal information the disclosure of which has not relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information: Provided that the information, which cannot be denied to the Parliament or a State Legislature shall not be denied to any person."

Details of Religion and caste sought by the applicant fall under exemption from disclosure of information and hence cannot be furnished.

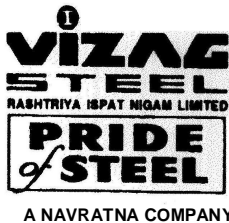
