This has reference to Ministry of Home affairs notification published in Gazette of India Extraordinary Part 2 Section 3 dated 4th Oct 2007 regarding State Emblem of India (Prohibition of Improper Use) Act 2005 (50 of 500) whereas Clause 10(2) Restriction on the use of Emblem of said notification says that no Public Sector undertaking use the Emblem in any manner, and whereas RINL (Vishakhapatnam Steel Plant) being a public sector undertaking (enterprise) under Ministry of Steel. Kindly provide justification for presence of National Emblem on your website.

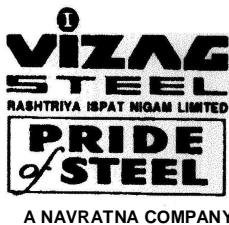
