The date of declaration of final results against Rectt. Advt. No.01/2020 is not yet decided.

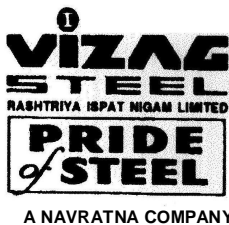
**Query. No. 3:**

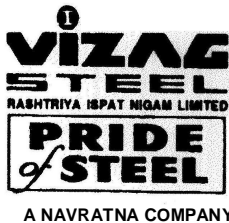
