**Query. No. 3:**

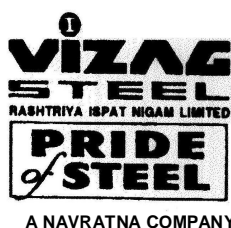
How many organisations / companies expressed their interest for supply of raw material / working capital? Please provide the details of Organisations.

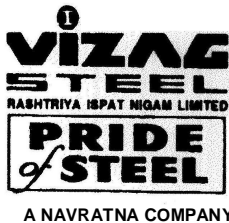
