Reply:

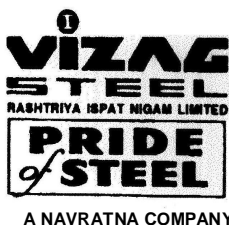
Promotion policy for Non-Executives and the Promotion Policy for Executives are two distinct policies independent of each other.

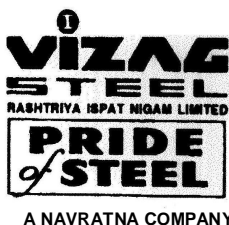

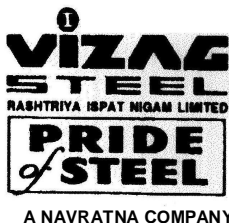
