Policies and guidelines:

Guidelines and rules established for issue of U passes are One(1) U pass to be issued for every 100 votes secured by the trade union during the trade union election and additional 6 passes will be issued to the recognised union. Issue of U passes in addition to the above mentioned passes will be decided by the Management upon the request of the trade union. Criteria for Eligibility and the process of application and approval: No such information is available.

Clarify whether individuals holding union passes are permitted to leave the plant premises at any time, irrespective of their working hours. If so, please specify the conditions or restrictions, if any, that apply to this privilege.

Reply:
