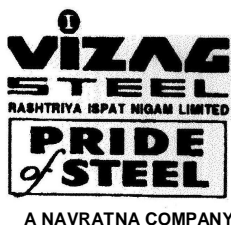
“The Query is not specific in nature”.

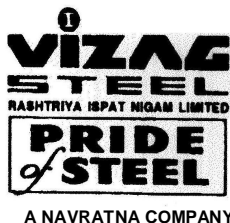
