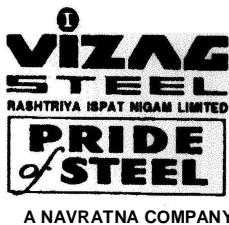
No, the Promotion Policy for Executives has not been amended recently.

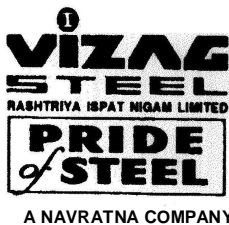
