In that period, after observing all my pay slips, it was coming to notice that there is a payment issue regarding the monthly salary, the organization holds the one-month salary. Even, I talk with accounts and HR personnel regarding this issue, they are unable to answer the questions. If you want a clarification, please check all my pay slips and wages released by the organization. While given the resignation also, organization retain the earlier year bonus amount around Rs.31000, in the name of pending arrears of Bonus amount for 2022, till now the arrears were not cleared and I am unable to communicate accounts personnel. It is requested to you please give the clarification regarding all amounts I received and retained from the organization in proper annual statement.

Reply:

"The Applicant is asking clarification about some issues. It is hereby submitted that under the RTI act, information can be provided. However, clarification cannot be provided under the purview of the RTI Act 2005.
