Kindly confirm that the land proposed by my firm had boundary wall which was verified by the land inspection team on their visit?

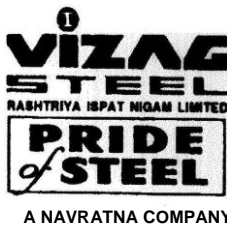
Query No.8:

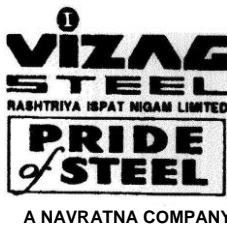
