Sub: Order of the 1ST Appellate Authority on the off line appeal filed by Sri T. Vinodh Kumar,
Dated 12.1.2022.

Ref: your Appeal letter dated 12.01.2022 addressed to the Appellate Authority, RINL.

Facts of the case:

Sri T.Vinodh Kumar had filed an offline RTI application with Regd. No. RINL.T/R/P/22/00002, Dt. 06.12.2021 seeking the following information:

1. Tejavath Lachiram, S/O Dhenya- During the construction of Visakhapatnam Steel Plant and Township, so many farmers lost their lands for whom compensation and employment provided.
2. The compensation given to Tejavath Lachiram, S/O Dhenya, but no employment provided to the legal heirs by which reason. If employment provided to any legal heir, the details may be provided.

Upon receiving the application from the applicant, CPIO wrote reply letter to the applicant vide letter dated 04.01.2022 stating that 1) the formation sought above is not available in compiled form and would disproportionately divert the limited resources of RINL for compilation and hence cannot be furnished; 2) the information sought is not clear and appears vague hence no information can be submitted.

Grounds of Appeal:

The applicant has not mentioned any grounds in his appeal.

Analysis: The following are the observations noted from the appeal.

- a. The applicant has submitted his off line application dated 6.12.2021 to the in charge of Madharam Mines directly. Madharam Mines have forwarded the same to Mines HQ at Visakhapatnam. Mines HQ have furnished draft reply to CPIO. The same has been communicated to the applicant by the CPIO vide letter dated 04.01. 2022.


- b. While examining the application submitted at Madharam Mines, it is observed that whether the sought information pertains to Madharam Mines alone or to the entire VSP which may be very much voluminous.
- c. It is also noted that the applicant has not given any particulars of the person quoted in his application by name i.e., Tejavat Lachiram who was said to have got compensation and also said to have not got any employment. This makes the RTI request as not clear and also appears to be vague.
- d. On further examination, it is noted that the request is about seeking information pertaining to HR department. Hence HR department has to examine the RTI application and provide suitable reply to the CPIO for onward communication to the applicant.

Conclusion:

- a. HR department is hereby advised to examine the RTI application and provide appropriate reply to the CPIO for onward communication to the applicant.
- b. CPIO is hereby advised to coordinate with HR department to obtain the reply and communicate to the applicant at the earliest.

With the above observations, the appeal is disposed off.
