



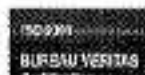

Sub: Extension of Bungalow facilities to Ex-D(P) & CMD Addl. Charge after superannuation.

1. Background:

Sri Kishore Chandra Das, Ex-D(P) & CMD Addl. Charge, Emp. No.124883, superannuated on 30.06.2021 vide n-1 has requested the following facilities for six (06) months from 1.7.2021:

- 1.1 Continuation of accommodation beyond superannuation, for 06 (4+2) months in terms of the Policy, in Bungalow No.D-7, Sector-7 w.e.f. 1.7.2021;
- 1.2 To provide existing facilities such as Telephone, Attendants etc., and other services as required for the Bungalow; and
- 1.3 Hired Car (Prefarably Swift Dezire).

2. Rule Position :

- 2.1 As per clause no.9.3A of House Allotment Rules, the permissible period for retention of the residence for retired employes is 4 months from the date of retirement at normal license fee (C-1).
- 2.2 Further, in the past, other CMDs were allowed all the facilities at the Bungalow viz., telephone, staff cars with drivers, attendants, security guards and other services available at bungalow for a period of two months after, on their request (C-2 to C-3).

3. Proposal:

In view of the above, following are proposed:

- 3.1 To allow all the existing facilities at Bungalow No.D-7, Sector-7 for up six (6) months (4+2) w.e.f. 01.07.2021;
 - 3.2 To communicate to Commandant, CISF to withdraw CISF Security force from Bungalow No.D-7 of Director (Personnel) from 1.7.2021;
 - 3.3 To provide Home Guards at Bungalow No.D-7 of Director (Personnel) for six months period w.e.f. 01.07.2021;
 - 3.4 To provide existing facilities such as Telephone, Attendants etc., and other services as required for the Bungalow for six months w.e.f. 01.07.2021;
 - 3.5 To provide a hired car for a period of six months w.e.f. 1.7.2021.
4. On approval, Town Administration Department and General Administration Department will be communicated to extend the above facilities.
 5. Submitted for kind consideration and approval of D (C) & CMD Addl. Charge.




