**Query No.1.** How much is the total power units consumption per year by all Departments combined for the last three years (2019 to 2021).

**Reply to Query No.1:** a) In the year 2019( i.e. Jan,2019 to Dec,2019) the total power units consumption by all Departments combined was 3451911MWh.

b) In the year 2020( i.e. Jan,2020 to Dec,2020) the total power units consumption by all Departments combined was 3041834MWh.

c) In the year 2021( i.e. Jan,2021 to Dec,2021) the total power units consumption by all Departments combined was 3611236MWh.

**Query No.2.** How much is the total electricity bill for all the Departments including each year for the last three years( 2019 to 2021).

**Reply to Query No.2:** a) In the year 2019( i.e. Jan,2019 to Dec,2019) the total electricity bill for all Departments was Rs.4079747632/-.

b) In the year 2020( i.e. Jan,2020 to Dec,2020) the total electricity bill for all Departments was Rs.3223660941/-.

c) In the year 2021( i.e. Jan,2021 to Dec,2021) the total electricity bill for all Departments was Rs.4122240603/-.

**Reply to Query No.3:** Rs.5.40 is currently being paid per KVAh of Electricity, as per APERC Tariff order for FY 2021-2022.


