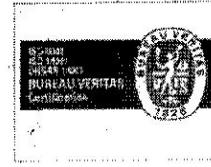

R Shyam Sundara Rao submitted a claim for Transfer expenses ^{of the same} and was processed as per company policy, against which Rs. 65,691 is with held as per court direction and the same was informed to Honorable court for further necessary action.
