Reply to Q. No. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 & 12:

The information cannot be provided under Section 8(1) (j) of the RTI Act, 2005 as the information sought is record of disciplinary proceedings/ enquiries etc which are personal information and hence is exempted from disclosure of information. Further it has no relationship to any public activity or interest.

The Supreme Court's judgment in *Girish Ramchandra Deshpande* v. *CIC*, Court held that details recording proceedings of disciplinary inquiries were personal information, outside the ambit of the RTI Act. Also confirms the above.
