Query No. 8:

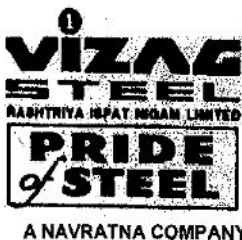
Please inform me the date by which my pension was required to be settled in accordance with the instructions and guidelines in vogue.

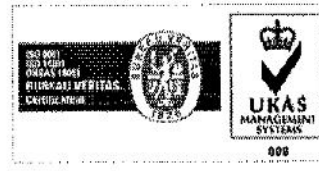

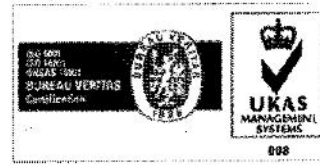
