**Reply to Q. No. 1 & 2:**

In case of executive employees as per Clause 7(a) of the Conduct Discipline and Appeal Rules, except in so far as may otherwise be specifically authorized by any law, no employee shall be a member of, or be otherwise associated with, any political party or any organization which takes part in politics, or assist any political movement or activity, or stand for election, as a member, of a local authority or a legislative body.

In case of non-executive employees as per Clause 27.71 of the Certified Standing Orders, contesting election to any elected office of the local bodies, legislative bodies, etc., while in employment of the Company without permission shall be treated as an act of misconduct.

The above information is furnished to the best of my knowledge and ability.

In case you desire to prefer an appeal against the information furnished, in pursuance with Clause no. 7(8) of RTI Act-2005, you may do so to the Appellate Authority designated by VSP as per details furnished below within a period of thirty days.
