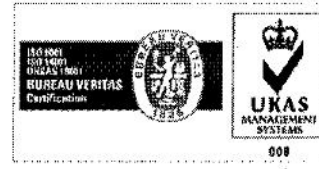

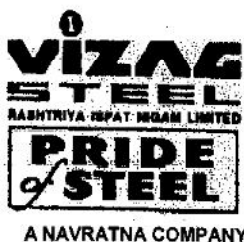
**Query No. 4:**
