HR POLICY CIRCULAR NO. 15/20

Sub: RINL EMPLOYEES PENSION(DEFINED CONTRIBUTION) SCHEME

The Clause 12(1) of the RINL Employees Pension(Defined Contribution) Scheme stands amended as under:

Clause No.	Existing	Amended
12(1)	A member/ beneficiary who does not clear the dues of the company on separation will be eligible for Pension Corpus only after clearing dues from the Company.	Member/ beneficiary will be eligible for Pension Corpus only after clearing his dues to the Company. However, any amount due to RINL. the Company reserves the right to set off such dues from the employer's contribution and the employee's contribution including interest accrued thereon, if any. This will be adjusted before transferring the fund to RINL ESBF Trust.

2. Other terms and conditions under the RINL Employees Pension(Defined Contribution) Scheme shall remain unaltered.
3. This issues with the approval of the Competent Authority.
