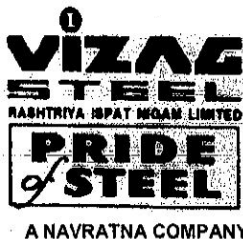
**Reply to Q. No. 1, 2 & 3:**
