Query No. 3:

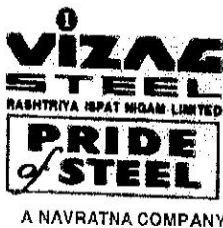
How much KMs may be used by the user for official purpose?

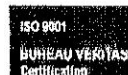
