**Query No. 2:**

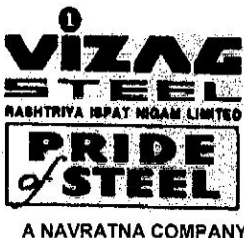

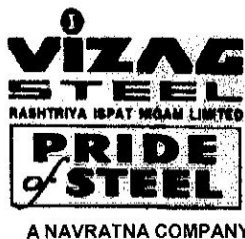
