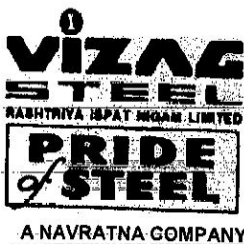
Yes, Lands under possession of RINL has been allotted to various outside agencies on lease basis.


