As there are several contracts in CDY, it is not clear as to which contract, the query is referring to. Sand or any other materials were used as per the laid down terms/specifications of the contracts.

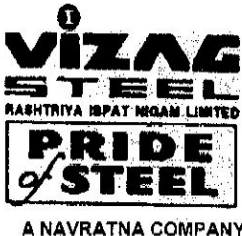
Query. No. 2:

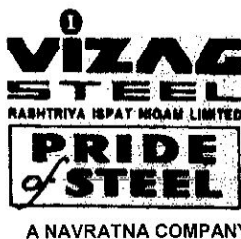
