The above information is furnished as received from the concerned DPIO / Department.

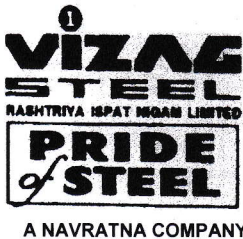
