Query. No. 3:

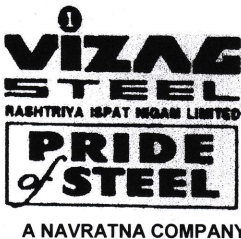

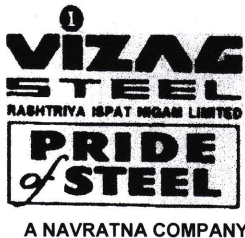
