



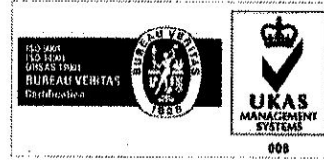

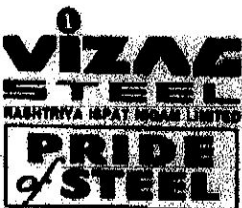
**Reply:**


