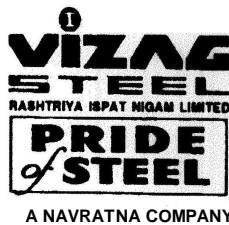
Reply:

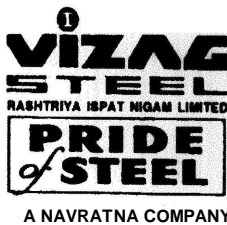
