Reply for Q. No. 1, 2, 3, 4 & 5:

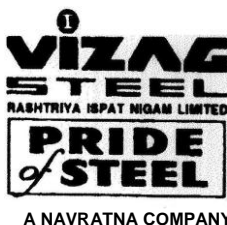

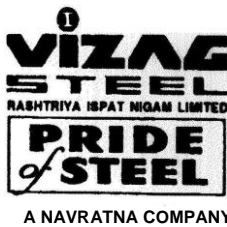
