REPLY OF THE CPIO IN THE ONLINE RTI APPLICATION NO.MOSTL/R/E/24/00042 DATED 05/04/2024 FILED BY MR R K GIRI WITH CPIO, MINISTRY OF STEEL WHICH WAS TRANSFERRED ONLINE TO RINL

Your online RTI application dt.5.4.2024 addressed to CPIO, Ministry of Steel was transferred online by Ministry of Steel to RINL on 05.04.2024. The same was registered in RINL as RINLT/R/T/24/00014. Vide reply dt.20.04.2024 the available information pertaining to RINL in respect of Query No.1 was furnished. Since the information sought in Query No.2 and 3 are not pertaining to RINL and not available with RINL, it was informed that information sought is not available with RINL.

On 19.04.2024 your same application dt.5.4.2024 was once again transferred to RINL by Ministry of Steel and the same was registered in RINL as RINLT/R/T/24/00018. Replies are furnished below:

Query. No.1: Kindly provide detailed information on the process of appointment of trade union members as employee representatives in NJCS.

Reply : In RINL, The names of two representatives (one as member and other as alternate member) from the Recognized Union will be sent to National Joint Committee of Steel, New Delhi as representatives of Trade union of RINL. Accordingly, these representatives will attend the meeting as per the communication from NJCS, New Delhi.

Query. No.2: Please furnish information regarding the rules or labour laws governing the allotment of three nominated seats to each of the labour /trade union INTUC, AITUC, HMS, CITU and BMS within NJCS

Reply : Information sought is not available with RINL.

Query. No.3: Despite the provision of recognized unions in all units of SAIL and RINL, I request information about any laws or regulations made by the ministry of Steel Regarding the allotment of three nominations quota seats to the five unions (INTUC, AITUC, HMS, CITU and BMS) within NJCS.

Reply : Information sought is not available with RINL.


