REPLY OF THE CPIO IN THE ONLINE RTI APPLICATION NO.MOSTL/R/E/24/00050 DATED 22/04/2024 FILED BY MR R K GIRI WITH CPIO, MINISTRY OF STEEL WHICH WAS TRANSFERRED ONLINE TO RINL

Your online RTI application dt.22.4.2024 addressed to CPIO, Ministry of Steel was transferred online by Ministry of Steel to RINL on 22.04.2024. The same was registered in RINL as RINLT/R/T/24/00019.

To your earlier RTI application dt.5.4.2024, the available information relating to RINL ie., Query No.1 was furnished on 20.4.2024 and it was informed that information sought pertaining to Query No.2 and Query No.3 is not available with RINL.

Query. No.2: Please furnish information regarding the rules or labour laws governing the allotment of three nominated seats to each of the labour /trade union INTUC, AITUC, HMS, CITU and BMS within NJCS

Reply : Information sought is not available with RINL.

Query. No.3: Despite the provision of recognized unions in all units of SAIL and RINL, I request information about any laws or regulations made by the ministry of Steel Regarding the allotment of three nominations quota seats to the five unions (INTUC, AITUC, HMS, CITU and BMS) within NJCS.

Reply : Information sought is not available with RINL.

This is once again to reiterate that the information sought pertaining to Query No.2 and Query No.3 does not pertain to RINL and hence cannot be furnished. However, this is to inform you that your application has been transferred back to Ministry of Steel on 25.4.2024 as per Section 6(3) of RTI Act 2005 requesting to furnish the relevant information.

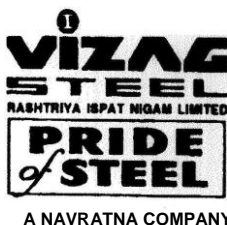

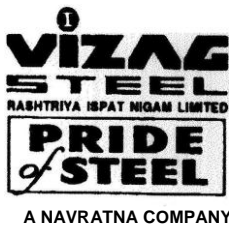
