# REPLY OF THE CPIO IN THE ONLINE RTI APPLICATION DATED 01/05/2023FILED BY MR. T V NAGESWARA RAOREGD. NO. RINLT/R/X/23/00003

### Query:

We are happy to some extent that the Hon. Minister for Steel, Govt.of India, during his visit to the Visakhapatnam Steel Plant and meeting held with him, he has very categorically announced on 13 April, 2023, that the GOVERNMENT IS NOT GOING AHEAD WITH THE DECISION OF PRIVITISATION OF THE STEEL PLANT. RATHER, MAKING EVERY EFFORT TO REJUNEVATE IT WITH FUTHER EXPANSION AND DEVELOPMENT.

On this development, the concerned sections have felt a little sigh of relief at that moment. And wanted a clear cut Order with drawing the earlier decision to privatise the Plant. In view of the latest statement made by the Hon. Minister for Steel, the people, political parties and the Trade Unions, demanded immediate withdrawal of the earlier privatisation decision of Govt.

While this is so, again on 14th April, 2023, there came a news in the Print & Electronic media stating that the Govt is sticking up to its earlier decision to privatise the Visakhapatnam Steel Plant This statement again created unrest, tension and uproar in the sections concerned.

This has reference to your RTI application cited above forwarded by Ministry of Steel, furnishing you replies to some of your queries and requesting the CPIOs to furnish reply in respect of Query Nos. 2 & 4 directly to you.
