\* Additional amount of `5000/- per month as Honorarium in case of those coaches who are not VSP employees. Sports Department employees who are nominated as coaches will be eligible for Honorarium if they impart coaching only during other than working hours. Coaching sessions will be minimum two hours per day at least five days in a week, otherwise honorarium shall be paid on prorate basis.

## B. <u>Eligibility Criteria:</u>

The applicants should fulfil any of the following criteria to be eligible for appointment as a Coach in the respective Game/Sport:

- > Qualified Coach Certificate issued by NIS/BCCI/Association affiliated to the Indian Olympic Association.
- > Represented RINL for a minimum of five years in Inter-Steel (SPSB) Championship.
- Participated at Inter-University/National/International level in Senior or Junior Category. Persons getting eligibility under this criteria can be considered as õAssistant Coachö only and they shall be entitled for 95% of the total honorarium.
- C. <u>Period of Contract:</u> Engagement will be on Contractual basis for **ONE** Year from the date of joining. The same is extendable on yearly basis at the discretion of the Management. Each term will be a fresh contract and at the end of each yearly term, contract will be deemed to have been expired. In case of extension, the extended term shall be treated as fresh contract of service and not as continuity.
- **D.** <u>Termination of the Contract:</u> The contract will stand terminated at completion of the prescribed tenure. The contract may also be terminated during the tenure with two monthøs notice in writing by either side.

- 4. Short-listed candidates should produce all the relevant original certificates / testimonials along with one set of photocopies at the time of interview.
- 5. Depending on the requirement, the Company reserves the right to cancel/restrict the engagement process without any further notice and without assigning any reason thereof.
- 6. Incomplete / illegible / unsigned / multiple applications / applications not in the prescribed format or without photograph or those received after last date will be rejected.

While applying, the candidates are advised to ensure that they fulfill the eligibility criteria and other requirements mentioned in this advertisement and the particulars furnished by them are correct in all respect.
