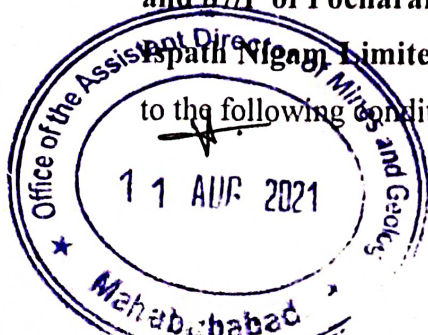


In exercise of the powers conferred under Rule 7(B) of Telangana State Minor Mineral Concession Rules, 1966 vide G.O.Ms.No.48 Ind. &Com.,[M.I] Dept., Dt: 26.07.2017, I hereby scrutinized the **Quarry Plan prepared by Sri. VCN Ranga Swamy, RQP for Dolomite over an extent of 384.46 Hectares i.e., an extent of 205.99 Hectares in Sy.No.179/P, 180, 181, 182/P and 183/P of Madharam (Vg) and Sy.No.407/P of Karepalli (Vg) Singareni (M) Khammam District and an extent of 178.470 Hectares in Sy.No.75/P of Seripuram (Vg) and Sy.No.71/P, 72/P, 74, 75/P, 76/P, 79/P, 80/P, 81, 82, 83, 84, 85, 86 and 87/P of Pocharam (Vg) Garla (M) Mahabubabad District applied by M/s Rashtriya Ispat Nigam Limited for the period of 5 years.** The Scrutinize of Quarry Plan is subject

to the following conditions.



1. *The Quarry operations shall be undertake in accordance with the self certified Quarry Plan.*
2. *The modification to self certified Quarry Plan during the operation of Quarry Lease shall be required prior Scrutiny of Deputy Director.*
3. *The lessee shall keep all records pertaining to Quarry Plan, Working Plans, Sections and other related documents at Quarry site and produce readily to the inspecting officers.*
4. *This Quarry Plan is scrutinized without prejudice to any other laws applicable to the quarry area from time to time whether made by the Central Government, State Government or any other authority.*
5. *The applicant and RQP are responsible for Concealed /Suppressed/ Circumvented/ Misrepresented in the Quarry Plan which may directly or indirectly affect the implementation of the Scrutinized Quarry Plan for execution of the work in the field.*
6. *It is clarified that this scrutiny of Quarry Plan does not in any way imply the scrutiny of the Government in terms of any other provisions of the Mines and Minerals (Development and Regulation) Act, 1957, or the Telangana State Minor Mineral Concession Rules, 1966 or Granite Conservation and Development Rules, 1999, Mineral Conservation and Development Rule' 1988 and any other laws including the Forest Conservation Act, 1980.*
7. *This Quarry Plan is scrutinised subject to strictly adhering to the relevant Regulations of MMR' 1961 and obtaining prior permission from the Director General Mines Safety whenever and wherever it is required.*
8. *The Scrutiny authority does not owe the responsibility with regard to wrong /insufficient information furnished or erroneous certificate made by the applicant or RQP if any and scrutiny is tentative subject to modifications on new findings at a later date, since the evaluation is done on random basis.*
9. *The applicant / lessee shall safeguard the structures, public buildings, roads, railway line, electric line and water bodies exists if any as per regulations of MMR' 1961.*
10. *The scrutiny and approval is only for the plans / schemes that the proponent proposed and intended to implement or carried out quarrying operations for the next consequent proposed period. Further, the approval does not cover excavated quantities / royalty payments and other regulatory / statutory issues.*
11. *At any stage, if it is observed that the information furnished, data incorporated in the document are incorrect or misrepresent facts, the scrutiny of the document shall be revoked with immediate effect.*
