 - (a) On-line Payment Gateway mode : (Open from 16th March, 2024 to 27th March, 2024) In order to have hassle-free payment of Fee, members are requested to prefer Online Mode of Payment.

User-ID is Employee Number and password is date of birth in the form of 'ddmmyyyy'. There is no need of submission of any document to HR-FSC in this mode.

Single Demand Draft for entire *family* (*multiple DDs not accepted*) in the name of "RINL-VSP" payable at Visakhapatnam. DD has to be submitted to HR-FSC. Please mention 'Name, Employee number, Mobile Number, e-mail' on the back side of the Demand Draft.

- 5. On receipt of the Enrollment Fee from the members, the payment of premium amount on behalf of the enrolled members will be made by RINL/VSP to the Insurance Company.
- 6. It may kindly be noted that delay in remittance of Enrollment Fee will result in a break in the policy and no mid year inclusion will be allowed.
- All members of Group Mediclaim Insurance Scheme of RINL/VSP are requested to ensure updation of particulars as and when any changes takes place in their mailing address / telephone number / e-mail etc. for HR-FSC records.
- 8. Information brochure and mediclaim card will be sent to the address of the member by the Insurance Company in the month of April, 2024.
- 9. Information about 'Top up facility' will be notified separately through Retired Employees Information System of Vizagsteel Portal and mobile message through 'SMS'.
